- ❖ Step 2 : KYC Verification: Bidder to upload requisite KYC documents. KYC documents shall be verified by e-auction service provider (may take 2 working days).
- ❖ Step 3 : Transfer of EMD amount to his global EMD wallet: Online /Off-line transfer
