that we have been able to reduce the HMR to below 25 now," said the deputy CM, who is also Health and Family Welfare Minister of the state.

He further said that due to improved healthcare facilities and schemes in the state, the IMR, which stood at 62 in 1999 came down to below 25. "We are making efforts to bring this down even further, at par with 15 which is prevalent in states that are developed in terms of health. To achieve this, we have set up more than 41 SNCU (special neo-natal care units). In rural areas, where special care is not available, we are taking help of private paediatricians to provide treatment to such children and we are paying them Rs 49,000 perichild," said Patel.

According to results of the the 2016 Sample Registration System, Madhya Pradesh topped the chart of IMR with 47. Assam (44) and Uttar Pradesh (41) too had high higher IMR than the national average of 34. In Rajasthan, itstood at 41, while it was 10 and 8 in Kerala and Goa respectively.

The deputy CM said that infants being referred from private hospitals to state governmentrun hospitals was also one of the reasons for higher number of deaths in the latter. He said that in the PDU Hospital in Rajkot, 804 births were recorded in December 2019 and out of them,

be admitted to SNCU owever, 160 infants were rered to the government hospifrom other private hospitals. said that out of the total 388 ants admitted to the SNCU, died. That, he said meant y 28 per cent infants died. hilarly, the figures in the nedabad civil hospital were 9 births, 172 admissions to CU and 243 infants referred moutside. Of the total 415 adtted to the SNCU, 88 or 21.2 cent died.

Patel said that every year, 12 n births are recorded in the te on an average and around ,000 infants die. He added that day, 99 per cent of deliveries in e state are done in a hospital or nursing home.

Minister of State for Health, Kumar Kanani, said that IMR was high in Surat among those infants referred to government hospital from private hospitals. "In the civil hospital in Surat, 9,589 births were recorded and out of them, 352, or only 3.67 per cent, infants died last year. During the same period, 1,016 infants were referred to the civil hospital from private hospitals

in Ahmedabad Civil Hospital over the past three months... it is the responsibility of the government to ensure safety of human lives."

The statement further said, "Our government has not issued an irresponsible statement such as 'kids die in BJP ruled states as well or kids have been dying even during past government as well'... the Gujarat CM have not answered the questions of me dia and have not shown any sitivity despite the fact that children died in a month ir constituency..."
