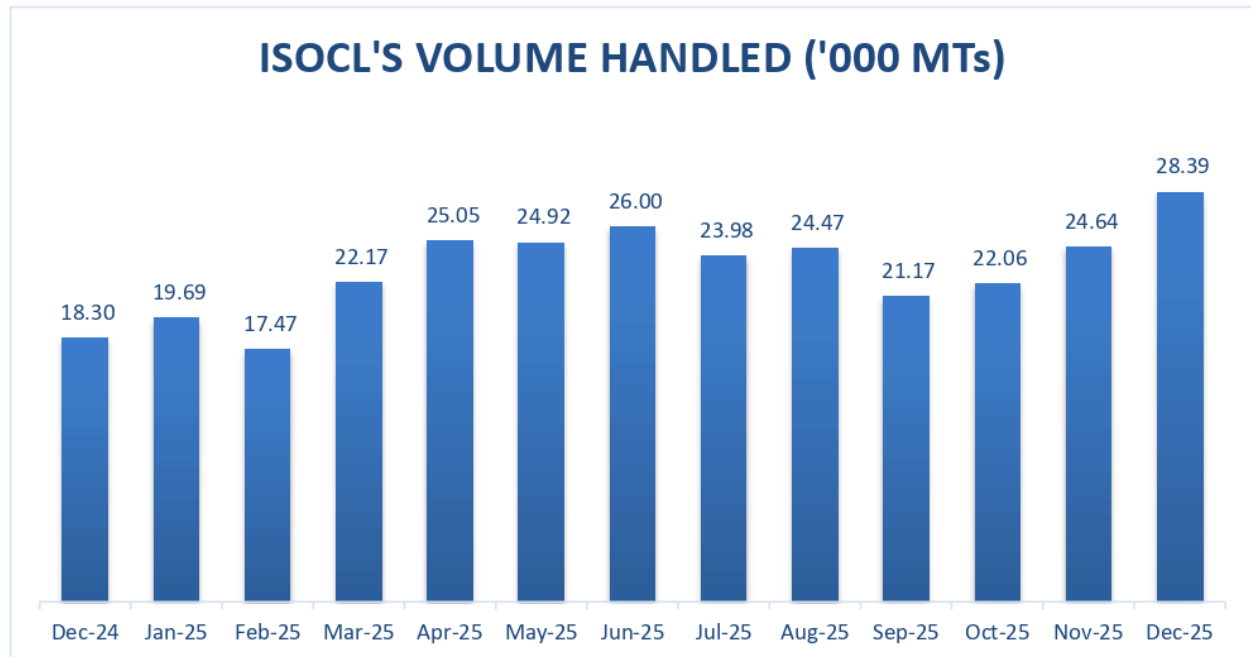

Key Highlights of Volume Handled:
