Rohit Shetty's firing case: Another culprit arrested from Pune

Mumbai, Feb 5 (IANS) In connection with the firing incident outside filmmaker Rohit Shetty's residence, the Mumbai Crime Branch has arrested another accused from Pune, taking the total number of arrests in the case to five, police officials said on Thursday. Mumbai Crime Branch's Anti-Ex- tortion Cell has arrested another accused from Pune. The accused has been identified as Asharam Fasle, who allegedly provided the gun to the person who carried out the firing.

With this arrest, a total of five accused are now in police custody. All five will be produced before the court today for remand.

Earlier, four accused had been arrested, whose police custody is

ending today. However, the person who actually fired shots outside Rohit Shetty's house is still absconding.

According to Mumbai Police, Shubham Lonkar, a close associate of jailed



gangster Lawrence Bish- noi and a fugitive criminal, has targeted at least five major Bollywood celebrities. These celebrities reportedly received threat- ening calls demanding ex- tortion money.

However, due to fear, none of them has filed a formal complaint with the police so far.

The firing incident at Rohit Shetty's Juhu bun- galow in Mumbai took place last Sunday. Police investigating the case said they have received intelligence inputs suggesting that several celebrities are hesitant to ap- proach the police. Investigators be- lieve the main ob- jective of the firing was to create fear across the film in- dustry.

A senior police officer said they have received in- puts that many people re- ceived threatening calls, but no one is coming for- ward to record statements or lodge complaints. If facts are concealed, it be- comes extremely difficult for the police to take suo moto action.

In one of Lonkar's so- cial media posts, warnings have come to light. How-

ever, Rohit Shetty him- self has denied receiv- ing any threatening calls.

In his post, Lonkar had written: "Ram-Ram, Jai Bajrang Bali. We warned Rohit Shetty several times not to in- terfere in our work, but he didn't understand. This was just the 'trail- er'. If he still doesn't lis- ten, the next bullet won't be fired outside the house—it will hit his chest directly. This is a warning to the entire Bollywood industry. Mend your ways in time."

Several police teams have been dis- patched to different parts of the country in search of the shooters. Officials believe that once the shooter is ar- rested, it will become clear who ordered the attack.

GPU shortage, not lack of funds or talent, choking India's AI dreams: Chadha

New Delhi, Feb 5 (IANS) Aam Aadmi Party MP Raghav Chadha highlighted the critical bottleneck hindering India's ambitions in Artificial Intelligence (AI) in the Rajya Sabha on Thursday, stressing that the primary constraint is not funding, capital, or talent but the availability of computational resources, particularly Graphics Processing Units or GPUs. Chadha pointed out that rising GPU costs and global supply chain disruptions are severely limiting India's data centre expansion and efforts to train advanced AI models. He noted that India's current pool of GPUs stands at approximately 34,000, a figure he described as very small compared to the scale required globally for developing cutting-edge AI systems. Through the Chair, he sought specific details from the Minister of State for Science and Technology on the targets, timelines, and geopolitical engagements initiated by the government to ensure predictable and secure access to these vital computational resources. In his response, Minister of State for Science and Technology (independent charge) Jitendra Singh acknowledged the concern as widely recognised, stating that GPUs form the core of AI development and related activities. He explained that under the India AI Mission, compute has been designated as a dedicated vertical or pillar due to its paramount importance. This pillar provides access to high-end computing services through empanelled providers, offering eligible users discounts of up to 40 per cent on costs. For larger models re-

quiring substantial compute, such as those with 30 billion or 65 billion parameters, access is also being facilitated from additional sources. Singh affirmed that the government remains fully aware of the challenges and is actively addressing them. He highlighted a key initiative where the private sector has been opened up to encourage investments from non-governmental entities.
