Bridge (Total Length 2280 meter) over River Gandak with other Major Bridges in approach road between Fatehabad in Paroo block & Chanchaliya in Saraiya Block in the district of Muzaffarpur on Engineering, Procurement & Construction (EPC) Mode’ (“**Project**”)

The accepted Bid Price for the Project is Rs.474.38 Crore, including GST.
