Since, pursuant to the scheme of arrangement, the Manufacturing facilities of the Company has been demerged and transferred to OCCL Limited (Resulting Company) w.e.f. July 01st 2024, the Company is no longer engaged in any business activity in Gujarat, hence the Board of Directors of the Company at its meeting held on May 28, 2025 decided to shift the Registered Office of the Company from State of Gujarat to the State of Uttar Pradesh subject to the approval of central government..
