

# Kapoor's wife, daughter get interim bail

The CBI had registered an FIR in March 2020 for abetting and criminal conspiracy as well as pressed corruption charges against DHFL and other accused persons, including Rana Kapoor. The CBI had filed its main chargesheet last year, where Rana and his daughter Roshini were made accused.

Recently, the CBI filed a supplementary chargesheet in the matter on August 20, 2021, and the court had summoned Rana's wife Bindu and Radha Kapoor Khanna, daughter of Rana Kapoor.

Vijay Agrawal, counsel for Kapoor's wife and daughter, argued that two of them were not in custody all along, they be granted bail as the probe is over and chargesheet filed and hence their custody is not warranted. The court fixed the date for next hearing on September 8.

# After namaz room in J'khand House, BJP asks for temple space

**Ranchi:** Protesting against the earmarking of a dedicated room for offering namaz inside Jharkhand's new assembly secretariat, the opposition BJP demanded on Saturday that Speaker Rabin-dra Nath Mahto allot space for a Hanuman temple on the assembly premises, report ASRP Mukesh & Jaideep Deogharia. The ruling JMM has, however, dismissed BJP's demand.

Ranchi MLA C P Singh accused the Hemant Soren government of "indulging in appeasement politics and religious polarisation".

"We are not against any religion and in this country, as per our constitution, everyone is free to practise the faith of their choice. Having said so, Parliament and Vidhan Sabhas are regarded as temples of democracy and not of any specific religion. Therefore, if the speaker can provide space for namaz, we also urge him to provide a place for the setting up of a Hanuman temple," he said.

Singh said he wasn't aware of any such designated place. "Even when I was speaker, there was no such place. Some MLAs had demanded an early adjournment of the House on Fridays to offer namaz, but I had said they were free to go but stalling the House would not be appropriate," he said. Former CM Raghubar Das, too, criticised the move to earmark a namaz room and warned of a massive stir against the provision. "BJP will not be a mute spectator to the state govern-

# NTA identifies 9 cases of impersonation in JEE, puts 419 under scanner

**New Delhi:** Amid a CBI inquiry into alleged malpractices during this year's JEE (Main) exams and arrest of several people linked to a private institute, the National Testing Agency has identified nine cases of alleged impersonation during the exams conducted during August 26-September 2 and blacklisted 23 test centres so far besides placing 49 exam centres and 419 candidates on the watchlist, sources in education ministry said.

After the ministry too received a few complaints of alleged impersonation, Education Minister Dharmendra Pradhan directed NTA to have a transparent system to address such concerns.

While denying any breach of its systems and leak of exam papers, NTA director general Vineet Joshi said: "These are cases on impersonation. Last year too, such a case came up in a centre in Guwahati. NTA can-

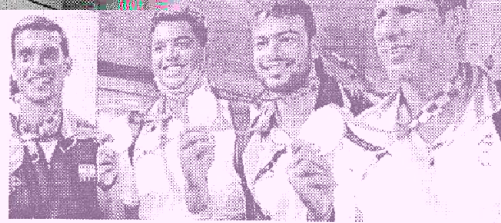
