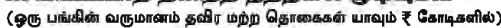

- The exceptional item for the quarter ended 30<sup>th</sup> June 2025 and the period ended 30<sup>th</sup> September 2025 refer to ₹1.29 Crores paid as compensation towards Voluntary Retirement Scheme opted for by employees during the first quarter of the current financial year. Also, exceptional item of ₹131.61 Crores for the financial year ended 31<sup>st</sup> March 2025 is on account of profit on sale of investment in subsidiary companies.
- The consolidated financial results for the quarter and period ended 30<sup>th</sup> September 2025 includes financial results of wholly owned subsidiary companies - 1) LMW Holding Limited, UAE and 2) LMW Aerospace Industries Limited, India and also includes financial results of step down subsidiaries such as LMW Textile Machinery (Suzhou) Co. Ltd, China and LMW Global FZE, UAE.
