
The above re-classification request is subject to consideration and approval by the Board of Directors of the Company, Shareholders approval and no-objection from Stock Exchange.

We, M/s A T Invoфин India Private Limited, holding 99443, equity shares constituting 0.43% of the paid-up share capital of M/s Inditrade Capital Limited ("the Company"), hereby submit this application requesting reclassification of our name from Promoter / Promoter Group category to Public Shareholder category under Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations").

 - h. there are no pending regulatory actions or proceedings against the Company;
 - i. we shall comply with such conditions as may be prescribed by SEBI, the Stock Exchange(s), or the Company from time to time.
2. There is no pending regulatory action against us.
 3. Whenever applicable, we shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 at all times from the date of re-classification, failing which, we shall automatically be reclassified as promoter/person belonging to the promoter group of the company.
 4. Whenever applicable, we shall comply with the conditions mentioned in the of sub-clauses (iv) and (v) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 for a period of not less than three years from the date of reclassification, failing which, we shall automatically be reclassified as promoter / person belonging to promoter group of the company.
