### Toll Revenue for Q3FY19

Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 6.2% to Rs. 2,757.6 mn in Q3FY19 from Rs. 2,597.8 mn in Q3FY18.

ARRIL - Toll revenue received (excluding car) in Q3FY19 has increased by approx 4.8% to Rs. 242.1 mn from Rs. 231.0 mn in Q3FY18.

AJTL - Toll revenue (excluding cars and state buses) received in Q3FY19 has increased by approx 4.8% to Rs. 100.1 mn from Rs. 95.5 mn in Q3FY18.

BHTPL - Toll revenue received in Q3FY19 has reduced by approx 1.5% to Rs. 295.7 mn from Rs. 300.2 mn in Q3FY18.

HYTPL - Toll revenue received in Q3FY19 has increased by approx 4.3% to Rs. 193.1 mn from Rs. 185.2 mn in Q3FY18.

MBCPNI - Toll revenue received in Q3FY19 has increased by approx 15.1% to Rs. 567.1 mn from Rs. 492.9 mn in Q3FY18. During Q3FY19, 18 Check Posts were generating revenue while during Q3FY18 16 Check Posts were generating revenue.

DPTL - Toll revenue received in Q3FY19 has increased by approx 1.4% to Rs. 481.9 mn from Rs. 475.4 mn in Q3FY18.

RPTPL - Toll revenue received in Q3FY19 has reduced by approx 7.7% to Rs. 262.4 mn as against Rs. 284.4 mn in Q3FY18.

SUTPL - Toll revenue received in Q3FY19 has increased by approx 13.8% to Rs. 310.8 mn as against Rs. 273.1 mn in Q3FY18.

BRTPL - Toll revenue received in Q3FY19 has increased by approx 24.2% to Rs. 133.5 mn as against Rs. 107.5 mn in Q3FY18.


