Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the Company has received a Quarry Lease Work Order from the Department of Mines & Geology, Government of Andhra Pradesh.

As per the work order, the Company has been permitted to undertake quarrying operations for extraction of Coloured Quartzite Blocks useful for cutting and polishing purpose over an extent of 21.012 Hectares (51.92 Acres) located at Survey No. 299, Hanumanthunipadu Village & Mandal, Prakasam District, Andhra Pradesh for a period of 30 years commencing from 06 January 2026 to 05 January 2056, subject to requisite statutory approvals and compliance with applicable conditions.
