- Consider, approve and take on record the Un-audited Financial Results (Standalone and Consolidated) of the Company for the quarter ended 30th June, 2025, after these results are reviewed by the Audit Committee of the Board;
- Consider the recommendation of Final Dividend, if any, for the Financial Year 2024-25.

Further, reference is drawn to our Communication no.
