Pursuant to the Regulation 30, 33 and 42 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), we hereby inform you that the Board of Directors of the Company at its Meeting held today i.e. **Thursday, August 07, 2025** have *inter-alia*, considered and approved:

1. Unaudited Financial Results (Standalone and Consolidated) for the quarter ended June 30, 2025. The copy of the said financial results together with the Limited Review Report thereon issued by the M/s. A. R. Sodha & Co., Statutory Auditors of the Company, are enclosed herewith as **Annexure I**;

The notice of the said AGM will be sent separately to the Stock Exchange and to the Members of the Company and will also be available on the Company's website at [www.comfortintech.com](http://www.comfortintech.com) in due course.

Please note that in terms of the Company's Code of Conduct for Prohibition of Insider Trading and pursuant to Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, as amended, the trading window for trading in securities of the Company will open on Sunday, August 10, 2025.
