Dear Sir/ Madam,

As per the latest Audited Financial Statements of the Company for the Financial Year ended March 31st, 2025, the paid up equity share capital of the company is Rs. 6,02,35,700 & the net worth of the Company is Rs. 26,12,62,144 which exceeds the prescribed limit of 25 crores.

The financial statements of the Company were approved on May 28, 2025. Accordingly, the Corporate Governance provisions shall become applicable to the Company within six months from May 28, 2025, i.e., during the financial year 2025–26. Hence, the Company currently falls under the cooling period as per the proviso to Regulation 15(2)(a) of the SEBI (LODR) Regulations, 2015.

Accordingly, the disclosures under Regulation 23(9) of the SEBI (LODR) Regulations, 2015 will become mandatory for the company from the quarter and period ending from Dec 31, 2025. The Company undertakes to comply with the said disclosure requirements within six months from May 28, 2025, being the date on which the Corporate Governance provisions become applicable to the Company.

Dear Sir/Madam,

This is to inform you that the Corporate Governance under Regulations 17 to 27 of SEBI (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018 read with BSE Circular dated 9th May, 2019 is not applicable to Olympia Industries Limited "the Company" for the years ended 31st March 2023, 2024 and 2025.

Further, we here by certify that the Company is exempt under Regulation 15 (2) of SEBI (Listing Obligations Disclosure Requirements) Regulations, 2015 as Corporate Governance provisions shall not apply to listed entities having paid up Equity share capital not exceeding Rupees 10 Crores and Net worth not exceeding Rupees 25 Crore, the last day of previous financial year. Accordingly, the corporate governance regulation is not applicable to the company for the financial years 31st March 2023 and 2024 respectively.

During the financial year ended 31st March 2025, the Net worth of the Company has exceeded Rupees 25 Crore and accordingly the Corporate Governance regulation is applicable to the company after the cooling off period.

As per Regulation 15(2) of the SEBI (LODR) Regulations, 2015, the Corporate Governance provisions specified under Regulations 17 to 27 and Schedule V shall be applicable to the Company after the expiry of six months from the date of meeting the prescribed financial or listing thresholds. As the Company has met the above criteria on 28th May 2025 (Date of approval of financial by the board for the year ended 31st March 2025), the Company is currently within the cooling period and shall ensure full compliance upon the expiry of the same.
