Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015, we would like to hereby submit the outcome for the Board Meeting held on Thursday, January 08, 2026 at 04.30 p.m. at the registered office of the Company at 615, Janki Center Off. Veera Desai Road, Andheri West, Mumbai, Maharashtra, India, 400053.

The brief details of the major business transacted at the Board Meeting were as follows:

1.	Considered and approved the proposal for change of name of the Company from “Fabtech Technologies Cleanrooms Limited” to “Fabtech Cleanrooms Limited” or any other name as may be approved by Central Registration Center, Ministry of Corporate Affairs and subject to necessary approval.
2.	Considered and approved the acquisition of an additional 9.2% equity stake in Kelvin Air Conditioning and Ventilation Systems Private Limited for a consideration of ₹4,65,06,000/-. Pursuant to the acquisition, the total shareholding of the Company in Kelvin Air Conditioning and Ventilation Systems Private Limited (“Kelvin”) has increased to 60.53%.  The details as required under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 are given in <b>Annexure I</b> to this letter.
3.	Considered and approved the retirement as a partner from M/s. Altair Partition Systems LLP.
