## CPIM's Brittas asks Jaishankar to take up baby Ariha's repatriation during German chancellor's visit

NEW DELHI, JAN 7: CPIM MP John Brittas has written to External Affairs Minister S Jaishankar urging him to make an intervention to secure the repatriation of baby Ariha Shah, an Indian citizen who has remained in foster care in Germany for over four and a half years.

Brittas highlighted that girl, now nearly five years old, continues to remain under the custody of German Child Services even after a German hospital concerned categorically ruled out any evidence of abuse and a court-appointed psychologist has recommended restoration of parental custody. The lawmaker's letter to the External Affairs Minister comes ahead of the scheduled visit of German Chancellor Friedrich Merz's two-day visit to India on January 12-13. German authorities took custody of Ariha Shah on September 23, 2021, when she was seven months old, following allegations of

physical abuse of the minor. Brittas said the visit of the German chancellor presents a timely and meaningful opportunity for constructive engagement on issues of mutual concern, including the protection of the rights of minor children, respect for family unity, and adherence to international child rights conventions.

"This situation is profoundly unjust and violates Ariha's rights under international law. As a passport holding Indian citizen, she is entitled to kinship care and the preservation of her identity, language and religion, as stipulated by the United Nations Convention on the Rights of the Child, to which both Germany and India are signatories," he said. "In her German placement, she is totally alienated from her heritage. Particularly outrageous is the fact that this Jain child is reportedly being fed a non-vegetarian diet, despite repeated requests by her family for a vegetarian diet," the MP said. Drawing

attention to the child's emotional vulnerability, Brittas noted that the girl's foster placement has been changed five times, depriving her of any stable caregiving environment.

"At present, the only consistent emotional support in her life consists of bi-monthly parental visits -- a fragile arrangement that now faces uncertainty due to the parents' visa limitations in Germany. This matter has also been raised by several Members of Parliament, reflecting broad national concern over the humanitarian dimensions of the case," he said.

Brittas emphasised that the forthcoming first official visit of the German leader to India presents a critical diplomatic opportunity to resolve the issue at the highest political level, and urged that the matter be taken up decisively during the bilateral engagement to ensure a humane and lawful outcome in the best interests of the child.

## Teen allegedly raped in Kanpur; local scribe held, cop's role under scanner

KANPUR, JAN 7: A local journalist has been taken into custody and a police constable's role is also under investigation in connection with the alleged abduction and gang rape of a 14-year-old girl in Kanpur's Sachendi area, officials said on Wednesday amid allegations of police apathy by the victim's family.

According to the complaint, the minor, a class 7 dropout, had stepped out of her home around 10 pm on Monday night when she was allegedly abducted by two men travelling in an SUV. One of the accused was wearing a police uniform. The girl told the police that she was taken to a deserted location near a railway track in Sachendi, where she was allegedly sexually assaulted inside the vehicle for nearly two hours.

She was later abandoned in an unconscious state outside her house, they said. The victim's brother said he found her lying outside the house

around midnight in a semi-conscious condition, according to the complaint. He said he immediately alerted the police by dialling 112, but alleged that no prompt action was taken.

The family later approached senior officials on Tuesday, following which an FIR was registered under sections related to kidnapping and gang rape. The girl's brother alleged that when the family informed the police personnel that one of the accused was a policeman, they were turned away from a local police outpost. Only after approaching senior officers was the case registered, he claimed, adding that the names of the accused were initially omitted from the complaint. The police said that efforts are on to identify and arrest the police constable, and stressed that the investigation is being conducted with complete transparency.

The victim has undergone a medical examination and the report is awaited, Deputy Commissioner of Police (West) Dinesh Tripathi said. "An FIR was initially registered

against unknown persons under sections related to abduction and gang rape apart from under the Protection of Children from Sexual Offences (POCSO) Act," Deputy Commissioner of Police (West) Dinesh Tripathi said. Initially, the case was registered on the basis of the complaint against two unidentified accused persons, he said. "During the investigation, the involvement of a police constable and a local journalist identified as Shivbaran came to light.

## Skeleton suspected to be of missing woman found in Lucknow

LUCKNOW, JAN 7: A skeleton, suspected to be that of a woman reported missing last month, was recovered from a mustard field on the outskirts of Lucknow on Wednesday. Police have sent

the remains for a DNA test to confirm the identity. The skeleton remains were found near Kubehra village.

According to a police statement, a villager named Chandraprakash alerted the police around 10.00 am after spotting the remains in a

field located in the Gomti river area. Police teams reached the spot and conducted a preliminary investigation. While the mutilated condition of the skeleton made immediate identification difficult, a saree found nearby led officials to believe that the remains are those of a woman. The saree was later identified as belonging to Poonam (30), wife of Pitambar, a resident of the

same village. The field is located approximately 300 metres from the family's residence, the police said. The police said Pitambar had lodged a missing person's complaint at the Nagram police station on December 13, 2025, stating that his wife had gone missing. Initial investigations revealed that Poonam, a mother of two, was in contact with a man from the same neighbourhood.
