We, Manjeera Constructions Ltd, a Company Listed on the BSE Limited bearing scrip code: 533078 would like to bring to your kind notice that our Company has received email from your good offices dated 03rd of March 2025, regarding discrepancies in the Corporate Announcement dated 01.11.2025 with regard to non-submission of the resignation letter of Company Secretary and Compliance Officer of the Company within 24 hours of the effective date of resignation.

In this regard, we would like to submit to your good offices the reason for the said delay in submission of resignation letter as follows:

As the Company is currently undergoing the Corporate Insolvency Resolution Process (CIRP), the management of the Company is vested with the Resolution Professional (RP). Mr. Birendra Kumar Agrawal, the Resolution Professional, has been designated for the further Compliances with SEBI.

However, shortly after his appointment, Mr. Agrawal experienced minor health issues that temporarily impeded his ability to oversee the Company's affairs effectively. This unforeseen situation resulted in a delay in submitting the resignation letter of the former Company Secretary.
