In furtherance of update to disclosure made on 8th March 2025 regarding Intimation received from Office of Commissioner Nagpur, we would like to inform you that Company has received a Show Cause cum Demand Notice Ref. No. 01/AE/NGP-II/GST/2025-26 dated 03/04/2025 under Section 74(1) of the CGST ACT 2017, MGST ACT, 2017, and IGST ACT, 2017, on 07/04/2025 alleging a tax demand of IGST, CGST and SGST is Rs 12,28,28,982/-

The Show cause notice states that our Company was misclassifying their “Snack Pallet” and “Extruded Snacks” under HSN 21069090 instead of correct HSN 19059030.

The Company is of the view that it has a strong case on merits to appeal against the said order before the appellate authority.
