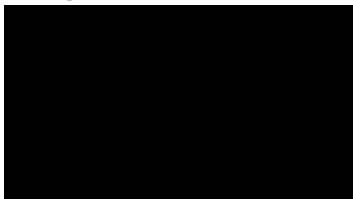

1995 custodial death case: Gujarat HC grants bail to 3 IAF officials



AHMEDABAD: The Gujarat high court on Friday granted bail to three Indian Air Force (IAF) officials, who were sentenced to life imprisonment by a special Central Bureau of Investigation (CBI) court last year for the custodial death of a cook in Jamnagar in 1995.

The bench of Justice SH Vora and Justice SV Pinto suspended the sentence of retired group captain Anoop Sood, retired sergeant Anil KN and serving sergeant Mahendra Singh Sherawat with an observation that the convicts "stand a fair chance of acquittal and the conviction recorded under sections 302, 348, 177 read with Section 120-B of the IPC is apparently erroneous and the conviction may not be sustainable."

The HC granted them bail on furnishing Rs 50,000 each and sureties of equal amount, said their advocate Nimit Shukla.

In May 2022, a special court in Ahmedabad held the three guilty of custodial death of a cook, Girja Rawat, who was residing in civilian quarters of Air Force - 1, Jamnagar.

The cook was accused of stealing 94 liquor bottles from the DSC mess of the Air Force.

The IAF authorities registered a police complaint with Jamnagar city police for the theft.

However, 12 IAF officials

took place and a chargesheet was filed against seven officials for murder and criminal conspiracy among other charges.

Later, the widow approached the high court for transfer of probe and the investigation was handed over to the CBI.

The central probe agency carried out further investigation and filed a supplementary chargesheet against eight accused persons, including the three officials, who have been convicted.

Sub-inspector in Rajkot abandons wife for giving birth to girl child, booked

RAJKOT: An assistant sub-inspector (ASI) with Rajkot police and his family members were booked under the Protection of Women from Domestic Violence Act after his wife lodged a complaint with the Mahila police station on Wednesday.

The complainant, Soniya Teriya, alleged that her husband and in-laws abandoned her after she gave birth to a girl child.

Police have booked Teriya's husband Devendra

three months after her marriage. About three years ago, she gave birth to a child. When her in-laws knew that it was a girl, they did not come to see the child and abandoned her. The complainant was currently living at her parent's house. She alleged that when she tried to go back to her husband's house for a better future for her daughter, her in-laws refused to allow her inside the house.

Teriya alleged that her in-laws started torturing her just

enter manholes. The government informed the HC that out of 152 such cases, compensation amounts have been disbursed in 137 cases.

The HC ordered the state government to pay the compensation to legal heirs of the deceased workers by the next hearing date.

The PIL was filed in 2017, but it was not heard further due to the demise of petitioner's advocate Hirak Ganju.

Last month, advocate SH Iyer requested the high court for early hearing of the case saying that many workers lost their lives recently.

During the hearing on Monday, ACJ Desai said, "Such types of activities are immediately required to be stopped."

'Take action against dummy schools'

AHMEDABAD: A member of the Gujarat Secondary and Higher Secondary Education Board (GSHSEB) has written a letter to the chief minister and the state education minister asking that the board investigate and act against dummy schools operating in the state. Privavadan Korat wrote there are many schools in the state, both affiliated with GSHSEB and other central boards, which are only on paper and give admissions to students from Class 11.

The letter says these schools attract students who want admissions to premier institutes like IIMS, IITs and medical colleges. It says these schools don't have premises or teachers, and conduct no academic activities. These schools somehow manage to get the board's approval for Class 12 science stream practical exams. Korat also alleged these dummy schools don't send their teachers for answer sheet assessment duty because the teaching staff only exist on paper.

Kin claim assault by mob in Gujarat's Dahod for being related to Bilkis Bano

VADDODARA: A group of men in Limkheda town of Dahod allegedly roughed up the brother-in-law of Bilkis Bano and his son at a marketplace on Sunday. Ajit Ganchi and his son Aasif, who had to be admitted to a private hospital for treatment of their injuries, claimed that they were targeted as they are related to Bilkis Ganchi, a resident of Randhikpur, said that he went with his son Aasif to the market in Limkheda to sell his goods. "At the entry gate, a man identified as Umesh asked for entry fee. I gave him Rs 500 but he didn't have change. This led to some argument and he asked me about my native town," Ganchi said.

"When I told him that I am from Randhikpur, Umesh began abusing me saying that I am from Bilkis Bano's family. Soon, he and other people started assaulting me and my son. They didn't even give back my money," he claimed, adding that he went to Randhikpur police station later to file a complaint. The police there, however, told him that he will have to approach the Limkheda police with the complaint.

While Ajit Ganchi suffered a fracture in his leg, Aasif received head injuries. "The man, who was giving gatepass, abused my father," alleged Aasif, adding that about 15 people attacked us later saying that we are relatives of Bilkis and threatened us to leave Randhikpur.

A senior police officer from Dahod said that the father and son were assaulted in a dispute over money. "They both are relatives of Bilkis, but the brawl has no connection with her. Ganchis were not assaulted because they are her relatives or because of Bilkis's legal case. It was about money."

SG Road drives mass state goods and services tax mop-up in Gujarat



AHMEDABAD: It might as well be called the Rich Road of taxes in Gujarat. Of the 103 GST units of the state commercial tax department, Unit 11 - which includes areas on SG Road from Vaishnodevi circle to Sarkhej and industrial areas of Sanand, Changodar and Bavla - topped by mopping the highest Rs 3,502 crore in state goods and services tax (SGST) collection in the year 2022-23. What's more, the second and third highest SGST collecting units in 2022-23 - 9 and 6 - were also in western Ahmedabad. Driven by highly industrialised clusters coupled with corporate headquarters and overall consumer spending, these three units accounted for Rs 9,967 crore of the net state revenue of 48,339 crore in the state.

Ahmedabad is divided into 23 units but the three units including areas from Ashram Road to Sanand and Vaishnodevi Circle to Bavla notched higher revenues than Jamnagar and Gandhidham, which stood fourth and fifth in revenue collection, respectively. The commercial tax department in Gujarat has

divided the state into 12 divisions, which in turn are subdivided into 103 units. According to data from the department, Unit-11 which includes parts of SG Highway is a tax bank, with Rs 3,502 crore of revenue, higher even than eight SGST divisions of the state. R M Prajapati, assistant commissioner Unit-11, said, "SG Road and areas such as Bopal, Sheela, Shilaj, Sindhu Bhavan, Science City, Vaishnodevi-Gota contribute at least 80% to the total revenue of Unit-11. The area has a number of corporate offices of electronics and mobile phone companies along with automobile and real estate majors, logistics firms and e-commerce entities which drive revenue collection." Prajapati said corporate offices of companies contribute the lion's share.
