3. Export incentives and duty drawback scheme are taken on cash basis.
4. The Company is engaged in trading of M.S. Window, Door and Ventilator Sections (Non-Alley) & Merchant Trade Activities. Besides the Company has share in Partnership & LLP engaged in Land development and real estate activities. Further the Company has also made investment in Body Corporate promoted by the Company in Bangladesh jointly with other parties.
