Subject: Intimation of Disruption in Operations and Labour Strike at Manufacturing Plant under Regulation 30 of SEBI (LODR) Regulations, 2015

Dear Sir/Madam,

In Pursuant to Regulation 30 read with Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Securities and Exchange Board of India Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 and in continuation to our previous submission to stock exchanges dated 24th September, 2025, we wish to inform you that, there has been disruption in operations at our manufacturing plant due to non-availability of critical raw materials essential for production. This shortage has adversely impacted our ability to maintain regular operations. As a consequence of the production halt, the Company is currently facing labour strike arising from non-payment of the wages and salaries to the worker.

We are actively working to resolve the supply chain constraints and to address the labour related concerns to restore normalcy at the earliest.
