Sampat Singh returns to INLD fold

Former minister and six-time MLA Sampat Singh on Wednesday rejoined the Indian National Lok Dal (INLD) and was appointed its patron in the presence of party chief Abhay Chautala and state president Ram Pal Majra. Addressing the media, Singh said he had "wasted 16 years" after leaving INLD to join the Congress and later the BJP. He quit Congress on November 2, alleging that sincere workers were sidelined under former CM Bhupinder Singh Hooda's dominance. Singh, who joined Congress in 2009 after 32 years with INLD, said he had lost faith in the party's leadership.

PM to flag off Vande Bharat to Khajuraho

Prime Minister Narendra Modi will visit Varanasi on November 7-8 to flag off the Vande Bharat Express connecting Varanasi and Khajuraho, linking pilgrimage sites like Vindhyachal and Chitrakoot. He will also virtually inaugurate three other Vande Bharat trains. After arriving in Babatpur at 5pm on Friday, Modi will review key development projects, including the Kashi ropeway and the international stadium at Ganjari. A grand welcome has been planned at six points along the route, with people showering flowers on the PM's motorcade. On Saturday, he will interact with students aboard the train and might visit the Kashi Vishwanath and Kaal Bhairav temples.

# AFTER 'SIR-FAROSH' IT'S SUFFRAGE

Far from the election campaigns and high-decibel claims of political parties, the first phase of Bihar polls on Thursday captured both the grit of voters and the gaps that successive governments have failed to plug. In Darbhanga's Kusheshwar Asthan constituency, voters braved flooded roads and difficult terrains to cast their votes, many with their children in tow. Behind the frustration lies a deeper pain: the story of migration, running like a fault line through the region.

Entire villages depend on sons working in Delhi, Punjab or beyond. "There are a lot of problems. Our sons go to Delhi and Punjab to work, and there is no one who cares. If the government provided some employment here, they would stay here in the village," said a voter.

While some voters battled floods, others celebrated the end of a long wait. In Munger's Bhimbandh, part of the Naxal-hit Tarapur seat, residents queued up with visible relief and excitement as a polling booth had finally returned to their village after 20 years.

As political parties spar over development claims and accuse each other of neglect, the images from the ground in Phase 1 of polls — drenched slippers, makeshift brick pathways, security personnel posted deep inside forests — offer a reminder that the stakes for ordinary citizens remain far more fundamental: roads, safety, work, and the basic dignity that comes with being heard.

## A se Apharan, F se Firoti, R se Rangdari: PM

Prime Minister Narendra Modi on Thursday said that members of RJD in Bihar have been schooled in "jungle raaj pathsala" where they learned "A se Apharan, F se Firoti (ransom), R se Rangdari (lumpen elements)."

At a public rally in Bhagalpur, PM Modi said, "Their school teaches P se Parivarvaad, G se

Ghotala. RJD's kakahara is katta, katuta, krurta, kushasan, kusanskar, corruption and Kushashan," he said.

PM Modi also recited "jungle raaj's Kakahara" with words like "katta, katuta, krurta, kushasan, kusanskar."

PM Modi also termed Lalu Yadav's family and Rahul Gandhi's family the two "most corrupt families," suggesting that the amount under Mukhyamantri Mahila Rozgar Yojana would've gone to their bank account. PM Modi also asserted that RJD and Congress were

supporting insurgency for their vote bank politics but his government was committed to deport them from the country.

"No expressway was constructed, no bridge built over Kosi, no development of any tourist circuit, no sports complex opened, no medical college, IIT, IIM or National Law University opened during the jungle raj," he remarked, while accusing RJD of spoiling the future of a generation altogether. "The youth's dreams are my resolution. They can write and keep this as my guarantee," Modi

stated. Addressing an election rally in Bhagalpur, Modi said that he got the bank accounts of women opened, while Bihar chief minister Nitish Kumar directly transferred Rs 10,000 to 1.4 crore of them to start new ventures.

## NDA preparing to steal votes: Priyanka

Congress leader Priyanka Gandhi on Thursday accused NDA of "preparing to steal" the assembly polls in Bihar, "just like they did in Haryana".

Addressing election rallies in Sitamarhi and East Champaran districts, Priyanka claimed that the Election Commission (EC) had colluded with the government to "weaken the constitution and democratic rights".

"Just like they stole the entire election in Haryana, they are preparing to do the same in Bihar by deleting 65 lakh votes from the rolls," she said.

The Haryana assembly polls last year were "stolen", Congress leader Rahul Gandhi had alleged on Wednesday, citing electoral list data to claim that 25 lakh entries were fake and the Election Commission col-

luded with the BJP to ensure the party's victory.

"Rahul Gandhi's fight is for you and truth, he is fighting the same battle that Mahatma Gandhi once fought," she asserted.

Priyanka claimed that those who were "betraying" this country would not be forgotten by the people and accused Election Commissioners Gyanesh Kumar, Vivek Joshi and S S Sandhu of "mocking the Constitution and democracy of India".

"If you think you will lead a comfortable life after retirement, that is not going to happen," she said.

She claimed that the NDA government would be ousted, and replaced by a government that would work for the poor, women and the youth if the Bihar assembly polls were conducted in a free and fair manner.
