**Sub: Order by the Adjudicating Authority (under the Prevention of Money Laundering Act, 2002), New Delhi in connection with the Provisional Attachment Order No. 11/2016 dated 11-06-2016 passed by the Enforcement Directorate in the matter of investigation against Kingfisher Airlines Limited, Dr. Vijay Mallya & Others under The Prevention of Money Laundering Act, 2002**

Further to our letter dated June 16, 2016, we would like to inform you that the Adjudicating Authority (under the Prevention of Money Laundering Act, 2002), New Delhi have vide its Order dated December 01, 2016, **received by us late evening yesterday**, confirmed the Provisional Attachment Order no.11/2016 dated 11<sup>th</sup> June, 2016 passed by the Directorate of Enforcement under Section 5 (1) of Prevention of Money Laundering Act, 2002 (PMLA) in the matter of investigation against Kingfisher Airlines Limited, Dr. Vijay Mallya & Others under the Prevention of Money Laundering Act, 2002.
