**Sub: Submission of Clarification to BSE on Delay and Queries Related to Financial Results  
30<sup>th</sup> September 2025**

Respected Sir/Madam,

This is with reference to your email dated **04th December 2025** regarding the non-disclosure of reasons for delay in submission of financial results for the period ended **30th September 2025**.

We would like to clarify the following:

**1. Timely Submission of Quarterly Results**

We, Jungle Camps India Limited, have been voluntarily uploading our quarterly financial results as part of our commitment to good corporate governance practices. Accordingly, we have filed our Quarterly Financial Results in compliance with Regulation 33 of the SEBI (LODR) Regulations, 2015. The Company submitted its Quarterly Financial Results for the quarters ended 30th June 2025 and 30th September 2025 well within the stipulated timelines prescribed under Regulation 33 of the SEBI (LODR) Regulations, 2015.

**2. First Query from BSE (Cash Flow Statement)**

Subsequently, we received a query from BSE on **28th November 2025** stating that the Cash Flow Statements (Standalone and Consolidated) were not received in PDF format. Upon receipt of the query, we immediately reviewed the matter and **submitted the financial results along with the Cash Flow Statements on the same day, i.e., 28th November 2025**.

**3. Second Query from BSE (Half-Yearly Results)**

Thereafter, we received another query from BSE on **01st December 2025** regarding submission of Half-Yearly Financial Results. To avoid any further ambiguity and to ensure full compliance with the Exchange's directives, the Company promptly **submitted the Half-Yearly Financial Results for the period ended 30th September 2025 on 01st December 2025**.

**4. Third Query from BSE (Clerical error)**

We also received an additional query highlighting a clerical error wherein the period was inadvertently mentioned as "period ended 30th June 2025" in one of the filings. We acknowledge this oversight and have since submitted the corrected file as required.

**5. Reason for Non-Disclosure of Delay**

Since the results for Quarter 1 and Quarter 2 of Financial Year 2025–26 were filed within the statutory timelines, an inadvertent overlap at our end led to the omission of the PDF attachment for the Half-Yearly data while submitting the same on the BSE Listing Centre. Upon noticing that the PDF attachment for the Half-Yearly data was missing, we promptly submitted the required documents without any delay.

The subsequent submission of the Half-Yearly Results was undertaken immediately in response to BSE's query. The Company had no intention of non-compliance or delaying the results.

**6. Assurance of Compliance**

The Company remains fully committed to adhering to the SEBI LODR Regulations and all directives issued by the Exchange. The lapse was purely inadvertent and without any intention of non-compliance. We have further strengthened our internal compliance and monitoring processes to ensure that such instances do not recur in the future.

**7. Condonation for Delay and Assurance for future compliance**

We, Jungle Camps India Limited, sincerely apologize for the delay in filing the Cash Flow Statement and Half-Yearly data. As this is our first instance of such non-compliance, we request you to kindly accept our apology. We further assure you that
