2. Ms. SHILPA AJAY BHATIA (DIN: 10377934), Ceased as DIRECTOR OF THE COMPANY with immediate effect."

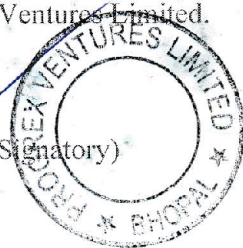

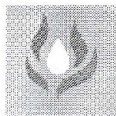

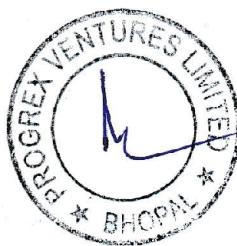
