This has reference to SEBI Circular No. SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97 dated July 2, 2025 for Special Window for facilitating Re-lodgement of Transfer Requests of Physical Shares by the Transferees during the Special Window period from July 07, 2025 till January 06, 2026. In line with the said SEBI Circular dated July 2, 2025 we have dealt with such requests during the said period as under:

On such scrutiny, we have noticed that none of them provided us the authentic documentary proof of their beneficial ownership of the shares of the Company such as Broker Contract Note, proof of payment of purchase consideration by way of cheque payment details/bank statements etc. The re-lodged transfer documents were not complete on account of various technical deficiencies.

As on the date of filing, we have not received the requested documents for processing the transfer request.
