We wish to inform you that, as part of the ongoing initiative to streamline the corporate structure of the PDS Group by eliminating non-operational and redundant entities and in accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), S. Oliver Fashion India Private Limited, a step-down subsidiary of the Company ("S. Oliver"), has been dissolved with effect from January 8, 2026.

The Company received the Order of the Hon'ble National Company Law Tribunal dated January 8, 2026, confirming the dissolution, today i.e., January 9, 2026. Consequently, S. Oliver has ceased to be a step-down subsidiary of the Company.

Please note that the above transaction does not have any material impact on the Company's financial position, as S. Oliver did not have any active business operations.
