

- (a) The Business as set out in aforesaid notice is to be transacted by the Members through postal ballot/ e-voting. Pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time and Regulation 44 of the SEBI (Listing Obligations and Disclosures Requirement) Regulations, 2015, the Company is providing facility for voting by electronic means through e-voting platform of Karvy Fintech Private Limited ("Karvy"). The necessary instructions for e-voting have been set out in the Postal Ballot Notice;
- (b) The Company has completed dispatch of the Postal Ballot Notice on Friday, February 8, 2019 through registered post and e-mail;
- (c) The voting including e-voting has commenced on Saturday, February 9, 2019 at 9:00 A.M. IST and will end on Sunday, March 10, 2019 at 5:00 P.M. IST.
