Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations")

In continuation to our earlier intimation dated August 28, 2024 and pursuant to provisions of Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 (Listing Regulations) read with SEBI Circular dated November 11, 2024, please note the Company has received an order dated February 05, 2026 via email today from Commissioner CGST (Appeals) Noida – 201305, against the appeal filed on November 21, 2024 by the Company, wherein revised demand of ITC of Rs. 1,95,48,739/- has been raised plus applicable interest and penalty of Rs 19,54,873/- against the original demand of Rs. 2,16,11, 820/- initially raised by Assistant Commissioner, CGST, Division –I, Noida, for contention of short payment of tax and Ineligible Input Tax Credit availed by the Company for FY 2019-20.

The Company will file an appeal against the aforesaid order before the Appellate Tribunal (GSTAT) in due course. As of now, there is no financial impact of the Order.
