Pursuant to Regulation 30 read with Clause 8 of Para B of Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI LODR Regulations”), as amended, and SEBI Master Circular No. SEBI/HO/CFD/PoD-2/CIR/P/0155 dated November 11, 2024, we wish to inform you that the Company has received letters dated February 09, 2026 from the Assistant Excise Commissioner (Molasses), State Excise Department in respect of its DwariKesh Nagar Unit (Bundki) and DwariKesh Puram Unit (Afzalgarh).

As per the said letters (Ref: DP Unit – 8560-63 and DN-8564), the Excise Department has compounded the violation relating to shortfall in the prescribed molasses storage capacity at the aforesaid units and has directed the Company to pay the compounding amount.

The total amount payable has been quantified at ₹2,50,000 (Rupees Two Lakh Fifty Thousand only) per unit.
