The Board was apprised that Mrs. Malti Bhatia, classified as part of the promoter of the Company, has submitted an application on 29th January 2026 seeking reclassification of her shareholding status from the promoter category to the public category. The said application was placed before the Board for its consideration on its meeting held on 4th February, 2026.

Upon review, it was noted that the application satisfies all the conditions prescribed under Regulation 31A(3) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Mrs. Malti Bhatia has also confirmed her undertaking to comply with the provisions of Regulation 31A(4) of the said Regulations following the approval of her reclassification.

Mrs. Malti Bhatia presently holds 10,800 equity shares of the Company, constituting 0.19% of the total paid-up equity share capital of the Company.
