NSE's Board to Meet on Feb 6 to Form IPO panel

New Delhi: The board of the National Stock Exchange (NSE) is set to meet on February 6 to formally initiate the process of its long-awaited initial public offering (IPO) following the regulatory clearance from markets watchdog Sebi. During the meeting, the board is expected to constitute a specialised IPO committee to serve as the central authority for the listing, market surveys and other related matters. This committee will be tasked with defining listing procedures and the criteria for appointing the merchant bankers and legal advisors required to draft the Red Herring Prospectus (DRHP), they added.

Bajaj Finserv Q3 Revenue Rises, but Net Hit by Provisions

Mumbai: Bajaj Finserv reported a flat growth in net profit in the December quarter of FY26,

with consolidated net profit slipping marginally to ₹2,229 crore, from ₹2,231 crore a year earlier, weighed down by higher provisions and one-time charges.

Total revenue from operations for

the company rose a strong 24% year-on-year to ₹38,708 crore, led by healthy growth in lending and insurance businesses. Interest income increased 17.5% to ₹20,449 crore. The group stepped up balance sheet

et buffers during the quarter. Bajaj Finance implemented a minimum Loss Given Default (LGD) floor across businesses, resulting in an accelerated expected credit loss (ECL) provision of ₹1,406 crore. In

addition, the group booked a one-time charge of ₹379 crore related to the new labour codes notified in November 2025.

Loan losses and provisions stood at ₹3,625 crore in Q3. Asset quality remained broadly stable, with gross NPAs at 1.21% and net NPAs at 0.47% as of December-end.

Insurance subsidiaries delivered steady growth. Bajaj General Insurance reported a 12% rise in gross written premium to ₹7,389 crore, while Bajaj Life Insurance saw new business premium grow 27% to ₹5,501 crore. Retail weight received premium rose 20% to ₹1,857 crore.





A Jashan to celebrate Jashn-e-Sadeh which is the Discovery Day of the Holy Fire by King Hoshang was held at 5 pm by the Sazeman-E-Jawanan-e-Zarthoshty-E-Irani, Mumbai on January 30 at the N.M. Petit Faslī Atash Kadeh Hall, Churchgate. The Jashan was performed by Er. Jahanbaksh Chitivala, Er. Aspi Surti, Er. Marazban Kanga and Er. Nozer Turel and was attended by over 200 humdeens.

After the Jashan, the Hon. Administrator Darayush Zainabadi welcomed the chief guest Arnava Mistry, former Trustee of the Bombay Parsi Punchayet, president of Young Rathestars and trustee of few other trusts on behalf of the Sazeman-e-Jawanan-e-Zarthoshty-E-Irani, Mumbai, on the occasion of the ancient, holy and auspicious Iranian Zoroastrian festival of Jashn-e-Sadeh. He also welcomed her daughter Yasmin and the special guest for the evening Godafarid Tehmtan Aresh who was present on the occasion having traveled to India from the US.

Zainabadi started the function by offering a petition to the Almighty in Persian and praying for good health, happiness, success and prosperity to all the followers of Asho Zarathustra which was translated in English by managing committee member Tehmina Peer, who also read out the report of the annual activities of the Sazeman.

Zainabadi then recited extracts from the 'Ahnava Gatha' in Persian and a para-wise translation in English was given by the vice-president of the Sazeman Arjuman Bakhtiar.

Managing committee member Jerry Engineer introduced chief guest Arnava Mistry who said that it was a privilege to be invited as chief guest on the auspicious day of Jashn-e-Sadeh. In her short speech, Mistry spoke about how fire was discovered by King Hoshang of the Peshadian Dynasty when he went on a hunting expedition and when he was passing through a jungle, he saw a huge snake-like dragon coming towards him. He hurled his spear at the creature, which stuck a huge stone resulting in sparks due to which the trees caught fire. The festival word Sadeh means 100 – as it falls exactly 50 days and 50 nights before the festival of Noruz. She said that Fire is revered not only by Zoroastrians but by other religions too.

She was felicitated by Khodayar Attaie, President of Sazeman, and this was followed by felicitations of other dignitaries who graced the occasion with their presence, notable amongst them being Gordafarid Tehmtan Aresh, wife of late Tahmtan Aresh, a shining star of the community who was known for his remarkable spirit, dedication, philanthropy and selfless contribution to the community. Also felicitated were Shirin Zareh Zarthoshti from Germany and Farzad Khodadadi from Australia, both of whom are staunch supporters of the Sazeman.

In conclusion, Jerry Engineer thanked the chief guest Arnava Mistry as well as the trustees of the Faslī Agiary for the use of the hall, photographer Dolly Soli Divecha, the manager of the Agiary Beji Vimadala, the Jam-e-Jamshed Weekly for covering the event as well as all the humdeens for attending in large numbers.

The programme came to an end after partaking of Jashan chashni and the customary Irani meva packets.
