**ORDER**

**CA 96/2025:-** This company application has been filed seeking correction crept in the order on account of typographical error at para 18 of the order dated 27.02.2025, wherein, the appointed date has been mentioned as 14.12.2024. Learned counsel for the Applicant submits that at two other places at para no. 4 as also in the RDs Report which has been reproduced in the order, the appointed date at para 2(f) has been mentioned as 14.12.2023, which is the correct appointed date.

Learned counsel further brings to our knowledge part 1 of the Scheme, where definitions and share capital are detailed and more specific to point no. 1.4 where the definition of appointed date has been given which means 14.12.2023. learned counsel submits that apart from Rule 11, Rule 154 of the NCLT Rules also enables such rectification sought.

To a specific query whether, the present Bench constituted of members other than the erstwhile members who have passed the order can direct such rectification, learned counsel for the applicant has cited the provisions contained at 150, 151 and procedure 8 of the C.P.C. as also on the order dated 15.09.2023, of the NCLT Mumbai, Bench, Court no. 1 in the case of '*Sangini Paidlimbs Private Limited*'. He further placed reliance on order dated 04.02.2025 in CA 312/2022 in CP 2012/2018 and contended





that though the company application vide which such order has been dismissed however, the bench has considered the issue before dismissal.

Learned counsel further submits that such typographical error which is on the face of record and has inadvertently crept in, in the subject order is rectifiable by the present Bench.

In the facts and circumstances of the case, in view of the enabling provisions under Rule 11 as also Rule 154, we deem it appropriate to direct the rectification sought for. Accordingly, the appointed date mentioned as 14.12.2024, at para 18, of the order dated 27.02.2025 be read as 14.12.2023. The CA is accordingly **allowed and disposed of.**
