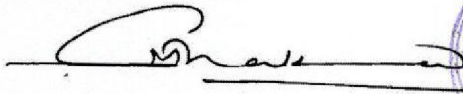

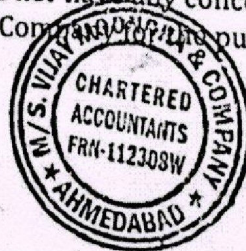
This is to inform that we would like to tender our resignation for the reasons as mentioned below

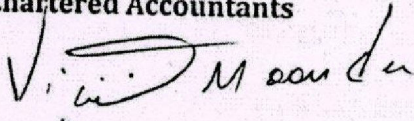
