ID: PO/ADJ/01-2026/CB/01357 - Dated: 09/01/2026 - Levy of Penalty U/s  
454 of the Companies Act, 2013 for delay of 2 days in filing of Form MGT  
– 15 in terms of Section 121(3) of the Companies Act, 2013 – Reg**

We draw your attention that The ROC, Coimbatore levied a penalty of Rs. 102000/- over the company and Rs. 78000/- in aggregate over 3 KMPs (ie. each KMP Rs. 26000/-) vide his Order ID: PO/ADJ/01-2026/CB/01357 dt. 09/01/2026 for delay of 2days in filing Form MGT-15.

It was represented to the ROC, Coimbatore that the delay was due to technical glitches, which was duly escalated in MCA portal in time, frequently existed in the MCA portal, during that part of time and the said form MGT -15 was filed immediately when the MCA portal enabled the same for such filing with additional fees and in such circumstances no default arises. It is relevant to note that Sunday was also taken a day of delay in the aforesaid delay of 2 days. The other legal submissions made by the Company were also not taken into consideration by ROC, Coimbatore in the aforesaid order passed.
