We are pleased to share business updates for Fabtech Technologies Cleanrooms Ltd. for the month ended **31 December 2025**, along with progress on our ongoing strategic growth initiatives.

1. During December 2025, the Company secured consolidated orders worth **₹75.51 crore**, led by the **Renewable Energy sector (₹33.00 crore)**, followed by **Pharma (₹13.50 crore)** and **Others (₹29.01 crore)**. From a business vertical standpoint, **₹17.34 crore** was contributed by **Cleanroom Partitions** and **₹58.17 crore** by **HVAC Systems**.
2. As of 31 December 2025, our consolidated order book stands at **₹257.17 crore**, comprising **Renewable Energy (₹119.42 crore)**, **Pharma (₹80.51 crore)**, **Data Centres (₹7.04 crore)**, **Semiconductors (₹10.21 crore)**, and **Others (₹39.99 crore)**.
3. Orders under active consideration total **₹454.53 crore**, with major opportunities in **Pharma (₹197.37 crore)**, **Renewable Energy (₹185.07 crore)**, **Semiconductors (₹51.64 crore)**, **Data Centres (₹5.03 crore)**, and **Others (₹15.42 crore)**.

We are pleased to highlight that Fabtech Technologies Cleanrooms Ltd. continued to build momentum in the Renewable Energy and Pharma sectors during December 2025, reflecting our strategic diversification across high-growth industries and our capability to deliver integrated cleanroom and HVAC solutions for advanced manufacturing facilities.

The Company has achieved a consolidated revenue of ₹39.86 crore in Q3 of FY25–26, against ₹ 38.33 crore recorded in Q3 of FY24-25.
