- I, Sudhansu Sekhar Panigrahi, Practicing Company Secretary (ACS 23187 /CP 19649) was appointed as Scrutinizer by the Company for conducting E-Voting process in a fair and transparent manner in terms of resolution of Board of Directors passed on 8th March, 2025.
- (2) The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to E-Voting and Postal Ballot on the resolutions contained in the Notice of Postal ballot and E-Voting dated 8th March, 2025.   - iii.The e-voting period remained open from 10 a.m. IST on Tuesday the 11<sup>th</sup> day of March, 2025 up to 5 p.m. IST on Wednesday the 9<sup>th</sup> day of April, 2025.
  - iv. The share holders holding shares as on the "cut off" date i.e. 7th day of March, 2025 were entitled to vote on the proposed 1 (One) resolutions as mentioned in the Notice of Postal Ballot dated 8th March, 2025.
