On this day, troops of 55 Battalion of CRPF launched an operation against Maoists in village Padiguda, PS Chintagupha, district Dantewada. As they neared the target, Maoists triggered IEDs and opened heavy fire from elevated positions, having laid a well-planned ambush. Over 200 Maoists attempted to encircle and wipe out the force. A reinforcement team led by Dy Comd. Shri Diwakar Tiwari rushed to the spot and reinforced the trapped troops. Displaying exceptional grit, the CRPF retaliated fiercely, forcing the Maoists to abandon their plan and flee. In this intense and prolonged battle, 10 bravehearts, including Dy Comd. Diwakar Tiwari, made the supreme sacrifice. The operation resulted in the elimination of 3 Maoists and recovery of arms, ammunition, and communication equipment. For their gallantry, Dy Comd. Diwakar Tiwari, SI Jaipal Singh, and HC Bharat Ram were posthumously awarded the President's Police Medal for Gallantry.
