**Subject: Claiming Exemption Under Regulation 15 (2) of The SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.**

Dear Sir/Madam,

We may kindly bring this on record that the Company is eligible to claim the exemption under Regulation 15(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI LODR Regulations”), from making compliances with the provisions of Regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 26A, 27 and clauses (b) to (i) and (t) of sub-regulation (2) of regulation 46 and para C, D and E of Schedule V of the SEBI LODR Regulations.

As on March 31, 2025, as per the latest Audited Financial Statements (2024-25), the Company’s paid-up capital is Rs. 9.06 Crores and the Net-worth is Rs. 4.10 Crores in *Negative*, which are below the prescribed threshold limits as prescribed under Regulation 15(2) w.r.t. the applicability of the aforesaid regulations.

In view of the aforesaid factual position the Company claims the below exemptions and no documents / disclosures are therefore submitted in this regard:-

- 1) The Annual Secretarial Compliance Report for Listed entity and its Material Subsidiaries as required under the provisions of Regulation 24A of SEBI LODR Regulations.
- 2) The Disclosure of related party transactions on a consolidated basis for the period ended on March 31, 2025 as required under Regulation 23(9) of the SEBI LODR Regulation.
- 3) Filing of Corporate Governance Reports as required under Regulations 27 of the SEBI LODR Regulations.
