The Unaudited Financial Results and the Limited Review Report were approved by the Liquidator on August 16, 2025. However, the prior intimation to be given two days before could not be given as there is no Board of Directors and the pending previous compliances are also a hindrance in further compliance matters. We are in touch with all the Statutory Authorities for the information regarding the pending compliances and gathering all the records so as the compliances can be done on time. We also request you to kindly provide us the list of any pending compliances so that we can get the same done. Any pendency of Statutory dues payable be also intimated so that those are taken as an expense of Liquidation Proceedings and can be paid.
