- During the year under review Company's Sugar Mill at Mothari, Bihar, remained nonoperational, and closed due to various factors, which mainly included cost ineffectiveness due to old plant and machinery, financial crunch and labour unrest at the Mill.
- The statutory auditor of the Company has issued Limited Review Report.
- Figure have been re-grouped/re-arranged wherever necessary.
- The Hon'ble National Company Law Tribunal, Kolkata Bench, vide its order dated September 27, 2024 (communicated on September 30, 2024), admitted an application for initiation of Corporate Insolvency Resolution Process (CIRP) against Shree Hanuman Sugar & Industries Limited. Pursuant to the said order, a moratorium has been declared and the powers of the Board of Directors stand suspended from September 27, 2024. The management and affairs of the Company are being conducted by the Resolution Professional under the provisions of the Insolvency and Bankruptcy Code, 2016. Accordingly, the financial results of the Company for the quarter and half year ended September 30, 2025, have been taken on record and signed by the Resolution Professional.
