1. Rescission of Resolution No. 05 Dated November 14, 2025, Pertaining to the Change of Registrar and Transfer Agent (RTA).

With reference to our earlier communication dated November 14, 2025, wherein we had intimated the Stock Exchange regarding:

- The discontinuation of services of our existing RTA, M/s. Integrated Registry Management Services Private Limited; and
- The appointment of M/s. Satellite Corporate Services Private Limited as the new RTA effective from November 17, 2025.
