The Company had completed dispatch on 11th December, 2025 of the Postal Ballot Notice dated Tuesday, 9th December, 2025 ("Notice") by sending e-mails to its shareholders whose name(s) appeared on the Register of Members and list of beneficial owners received from NSDL and CDSL as on Friday, 05th December, 2025 ("Cut-off date"), for seeking their approval of business as per Notice.

2. In compliance with the MCA circulars, the Notice were sent only through e-mail to those Shareholders whose email addresses were registered with the Registrar and Transfer Agent/ Depositories as on the Cut-off date with an instruction to cast their votes through e-voting system only as provided by CDSL.
3. In accordance with the Notice, the e-voting was started at 09:00 am (IST) on Saturday, December 13, 2025 and ended at 05:00 pm (IST) on Sunday, January 11, 2026 ("Voting Period").
