Monday, January 12, 2026, has, inter alia, approved investment in the equity shares of Monarch Network Asset Management Private Limited, the wholly owned subsidiary of the Company, up to an amount not exceeding Rs. 59 crores by way of subscription to rights issue up to 1,00,00,000 equity shares of Rs. 10 each, at an issue price of Rs. 59 per equity share (including a premium of Rs. 49 per share).
