

**Sub: Scrutinizer's Report on Postal Ballot through Remote E-voting conducted pursuant to the provisions of Sections 108 & 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (as amended), Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the relevant MCA circulars issued thereunder**

### **Responsibility of the Management**

The management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and the Rules made thereunder in relation to exercising of voting rights through electronic means on the Resolution, as set out in the Postal Ballot Notice dated 8<sup>th</sup> December 2025.



### Responsibility as a Scrutinizer

My responsibility, as a Scrutinizer for the Postal Ballot through Remote E-voting process, is restricted to the preparation of the Scrutinizer's Report on the votes cast "in favour" or "against" the Resolution, as set out in Item No.1 of the Postal Ballot Notice dated 8<sup>th</sup> December 2025 based on the reports generated from the e-voting system provided by MUFG Intime India Private Limited ("MIIPL"), the Authorized Agency engaged by the Company for providing remote e-voting facilities.

Further in addition to the above, I submit my report as under:

- The Postal Ballot Notice dated 8<sup>th</sup> December 2025 along with necessary statements setting out the material facts under Section 102 of the Companies Act, 2013 were sent on Thursday, 11<sup>th</sup> December 2025 by MUFG Intime India Private Limited, the Registrar & Share Transfer Agent through electronic mail to those members whose names appeared in the Register of Members / List of Beneficiaries as on Friday, 5<sup>th</sup> December, 2025 ("cut-off date") and who had registered their email ID with the Company / RTA / Depositories in compliance with the MCA Circulars. The Company has also placed the notice of the Postal Ballot on the website of the Company.
- The shareholders of the Company holding shares as on the "cut-off" date on Friday, 5<sup>th</sup> December, 2025 were entitled to vote on the proposed resolution as set out in Item No. 1 of the Postal Ballot Notice.
- The remote e-voting period remained open from Friday, 12<sup>th</sup> December, 2025, 9:00 AM to Saturday, 10<sup>th</sup> January, 2026, 5:00 PM (both days inclusive). During the said period, the members of the Company, holding shares in physical and / or in dematerialized form, as on the cut-off date i.e. Friday, 5<sup>th</sup> December, 2025 were entitled to vote on the resolutions set out in the Notice of Postal ballot through remote e-voting.
- The e-voting module of MIIPL was disabled on Saturday, 10<sup>th</sup> January, 2026 at 5:00 PM and I, as the Scrutinizer, unblocked the votes cast, on Saturday, 10<sup>th</sup> January, 2026 at 5:55 PM in the presence of Mr. Selten Jayaraj A and Ms. Vinothini S, who are not in employment of the Company in accordance with Rule 20(4)(xii) of the Companies (Management and Administration) Rules, 2014 (as amended).


