Q3 & 9MFY25 Earnings Release

ECOS Mobility reports around 23% YoY Growth in Q3FY25 Operational Revenue

Delhi, February 12, 2025: ECOS (India) Mobility & Hospitality Limited ("ECOS" or "Company"), one of the largest chauffer driven mobility providers to corporates in India, today announced its unaudited financial results for the third quarter and nine month ended December 31st, 2024.

Performance Highlights for the third quarter ended December 2024:

- Revenue from Operations increased by 22.88% to ₹1682.47 Mn in Q3 FY25 compared to ₹1369.20 Mn in Q3 FY24. This growth was driven by both businesses of Chauffeur Car Rentals & Employee Transport Solutions
- EBITDA stood at ₹216.14 Mn in Q3 FY25 compared to ₹211.12 Mn during Q3 FY24
- EBITDA Margin subdued by 257 bps to 12.85% in Q3 FY25 as against 15.42% in Q3 FY24, led by increased one time operating and indirect costs incurred during the quarter.
- PAT stood at ₹127.77 Mn in Q3 FY25 compared to ₹141.47 Mn in Q3 FY25. Decrease in PAT is largely on
 account of increase in depreciation with the new fleets added during the quarter, increase in direct and
 indirect expenses and reduction in unrealized gain on investments.

Performance Highlights for the nine month ended December 2024:

- Revenue from Operations was ₹4767.23 Mn in 9M FY25 compared to ₹4054.33 Mn in 9M FY24, a year on year growth of nearly 17.58% aligned to growth in the two core businesses during the first nine months of FY25
- EBITDA stood at ₹659.20 Mn in 9M FY25 compared to ₹677.83 Mn during 9M FY24
- EBITDA Margin was at 13.83% in 9M FY25 as against 16.72% in 9MFY24. Apart from operating & indirect costs incurred, increased competitiveness in the sector also impacted the EBITDA
- PAT stood at ₹420.3 Mn in 9M FY25 compared to ₹445.62 Mn in 9M FY24 leading to fall in PAT margins



by 216 bps in first nine months of the year as compared to same period last year. This is on account of increase in depreciation cost of the new fleets, increase in direct and indirect expenses and reduction in unrealized gain on investments.

Commenting on the overall performance of the Company, Mr. Rajesh Loomba, Chairman and Managing Director, ECOS said,

"I am pleased to share that our revenues have grown 23% in Q3FY25. We have been able to grow despite increased competition that has impacted pricing in existing markets combined with us entering into new markets in India, highlighting our strong foothold in this dynamic industry.

Presently, we are focusing on generating demand from corporate and the travel industry, thereby enabling us to scale our operations across geographies. We have successfully added 130 new clients in these nine months, across both our services of CCR & ETS.

As we move forward, we remain committed to raising the bar in service quality through ongoing investments in technology, employee training and fleet expansion. These efforts will ensure that we continue to meet the evolving needs of our clients and support sustainable growth for the company in the long run.

Lastly, I'd like to express my sincere gratitude to all our stakeholders and especially the entire ECOS team, for their continued trust and support in driving our success."
