Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with Para B of Part A of Schedule III, we hereby inform that the Board of Directors of the Company at its meeting held on February 12, 2026 has accorded in-principle approval for setting up a new Phosphoric Acid Plant with a proposed capacity of 300 Metric Tonnes Per Day (MTPD) at Thal Unit.
