# Electronics firms up in arms over new e-waste policy

INDIA IS THE third-biggest e-waste generator behind China and U.S. But government data showonly 43% of the country's e-waste last year was recycled and at least 80% of the sector comprises informal scrap deal-ers, whose methods can pose environmental and health risks. 
