पुणे : प्रतिकूल हवामानामुळे हापूस आंब्याप्रमाणे केशर, पायरी आणि रायवळ, गावराज आंब्यालाही फटका बसला असून, उत्पादनात सुमारे ३५ टक्क्यांपर्यंत घट झाली आहे. त्यामुळे खवऱ्यांची भिस्त प्राधान्याने परराज्यांतील आंब्यावरच राहणार आहे.
