## I have identified a problem area and am working on it: Neeraj Chopra

India's star javelin thrower Neeraj Chopra on Friday said he has identified a problem in his game and is looking to address it at the earliest, as he seeks to win a second world championship gold medal later this year.

Chopra, who is the strongest Indian medal hope in the September 13-21 showpiece in Tokyo, will be training in Prague and Nymburk in the Czech Republic for 57 days.

He will be heading out with his physio Ishan Marwah tonight and be based in the European country till September five at a total cost of ₹19 lakh.

"I have already identified the areas I need to work on. While throwing the spear I tend to fall too much on my left side. We need to work on that. In training I don't do that, but in competition, it happens because of the extra effort I put in," Chopra said.

The double Olympic medalist said he also needs to work on his consistency to hit the 90-mark more often.

"I have achieved 90m this year. But I need to be more



consistent to achieve it more often. I am continuously around 88-89m and my coach said he is happy, but I need to be more consistent," Chopra said during the launch of

Under Armour store here. Needless to say, his next big target is to finish on top of the podium at the World Athletics Championships.

"My next target is the world

championships and I want to win there. Before the world championships, I will plan with my coach and see which event I can compete to best prepare for it," Chopra said.

## GAUTAM GAMBHIR BACKS BCCI'S FAMILY RULE FOR OVERSEAS TOURS

India head coach Gautam Gambhir has backed the BCCI's directive to limit the presence of cricketers' families during long overseas tours, saying players must realise they are not on vacation but on national duty.

The BCCI introduced a revised travel policy after the Indian team's 1-3 defeat in Australia at the Border-Gavaskar Trophy, capping family members' stay to two weeks maximum for tours longer than 45 days. For shorter tours, the duration was restricted to seven days.

"Families' roles are important, but you've got to understand one thing. You are here for a purpose. It's not a holiday. You're here for a huge purpose. You've got very few people in that dressing room or in this tour that gets this opportunity to make the country proud. So yes, I'm not against not having families with us," said Gambhir during a conversation with Cheteshwar Pujara on Sony Sports Network.

Star batter Virat Kohli had earlier spoken in favour of having families accompany players, saying



personal support helps during high-pressure situations. Gambhir, however, stressed the importance of putting country before everything else. "It is important to have families, but if your focus is towards making our country proud and you have a much bigger role than any other thing, and you're committed to that goal, you're committed to that goal, I think everything else is fine. But for me, I think that cause and that goal is far more important than any other thing." On the

sidelines of the third Test against England at Lord's, Gambhir also admitted he finds it difficult to disconnect from the game, revealing he was thinking about team combinations minutes after India's comeback win over England in

the second Test at Birmingham. "That's a tough question. I still haven't understood how do I switch off because I never switch off and sometimes it's very funny and it's very weird," he said when asked how he unwinds. "Honestly, when we won the last test match, the moment we won the last test match, the first thing that came in my mind was that what is going to be the combination for the next Test?"

## AAI signs MoU with Amity University to support archer education

The Archery Association of India (AAI) on Friday signed a Memorandum of Understanding (MoU) with Amity University to offer certificate programmes and scholarships to archers, enabling them to pursue higher education without compromising their sporting careers.

The initiative aims to provide flexibility to senior, junior, and para archers, allowing them to balance academics with their rigorous training schedules.

Under the agreement, Amity University will offer tailored undergraduate and postgraduate programmes designed to accommodate the demanding routines of athletes. The university will also provide sports scholarships under the banner of 'CHAMPS', offering three tiers of financial support.

International-level players will be eligible for a 100 per cent scholarship, covering the full

programme fee. National-level athletes will receive a 50 per cent scholarship, while state and district-level archers can avail of a 30 per cent fee waiver.

"Our archers are doing well in both recurve and compound categories. Along with sports, education is also crucial. This collaboration will ensure that even archers from remote areas at the state, district, and national level can pursue online education," said AAI president Arjun Munda told reporters.

"Athletes often struggle to complete their education due to the demands of sport. Sometimes, a lack of education can affect their confidence. I am thankful to Amity University for extending this support through the MoU."

The online learning model offers flexibility with recorded lectures, allowing students to study at their convenience and take exams without interrupting their training or competitions. Additionally, Amity University Online will

offer a free certification programme in Sports Psychology to enhance athletes' mental strength and performance.

A dedicated academic counsellor will also be assigned to support archers with academic guidance, assignments, examinations, and technical queries related to the learning platform. Kisik Lee yet to sign contract: AAI secretary general Legendary Korean archery coach Kisik Lee, who has guided multiple countries to Olympic glory, is set to take over as India's recurve head coach ahead of the 2028 Los Angeles Games.

While Lee is expected to join the Indian setup in August, Archery Association of India (AAI) secretary general Virendra Sachdeva on Thursday said the contract is yet to be formalised. "He hasn't yet signed the contract. We are waiting for some approvals. It will be done soon," Sachdeva said.
